

ECO-RESPONSIBILITY

ECO-RESPONSIBILITY

Protecting the environment is becoming increasingly important in everyone's life and the Local Organizing Committee (LOC) of the 2025 World Masters Athletics Indoor Championships (WMACi25) is committed to conducting these Championships as responsible Eco citizens of the world.

With the media and modern communication technologies, saving paper seems to be an obvious way to contribute, but many of us are still reluctant to address it, especially when it comes to starting lists and results which, for the WMACi25 are systematically published on various web sites (WMA, LOC) and in the event before being available in print.

WMACi25 is no exception, and this is why every effort will be made to reduce the quantity of documents printed and distributed to the teams.

Other important information of general interest (e.g. schedule changes) will also be posted on the display panel in the Welcome Center. Thank you for your cooperation and for your contribution to this important cause.

To further our sustainability efforts, food waste from the concessionary kitchens at the WMACi25 will be diverted from the landfill. When food waste goes to the landfill, it produces harmful methane emissions which are 80 times more potent than carbon dioxide (CO2). The WMACi25 Local Organizing Committee, in partnership with O-Town Compost, is providing an eco-friendly food waste collection service that is convenient, odor, and pest free. Food waste will be hauled to a composting site in Alachua County, Florida, helping to reduce greenhouse gases and the need for permitting of more landfill space.

WORLD MASTERS ATHLETICS INDOOR CHAMPIONSHIPS

The World Masters Athletics Championships Indoor (WMACi) are held biennially. The WMACi are open only to men and women who are aged 35 years and over at the first day of competition and who are medically fit to compete. For the first time in the history of the WMACi, this event will be held in the United States of America, conducted over 8 days, March 23-30, 2025, in Alachua County, Florida.

WORLD MASTERS ATHLETICS

World Masters Athletics (WMA) was founded as the World Association of Veterans Athletes (WAVA) on August 9, 1977, in Sweden. The change of name of the organization to World Masters Athletics was made in 2001. The main responsibilities of WMA include:

- To organize, regulate and manage athletics for masters (women and men aged 35 and over).
- To sanction Master Athletics World Championships and other international athletics competitions for masters.
- To ratify and record masters world records in different five-year age categories, but also to keep statistics and other best performance records for masters athletes.
- 🌔 To encourage friendship, understanding and cooperation through masters athletics.

ABOUT ALACHUA COUNTY

Alachua County, located in the north-central part of Florida, is a vibrant and diverse area encompassing a total of 969 square miles. The county seat is Gainesville, which is home to the University of Florida, a major public university that plays a significant role in the county's economy and culture.

Alachua County was founded on December 29, 1824, and was named after the Timucuan word for "sinkhole." The county has a rich history, with several historical sites and museums that showcase the area's past. The city of Alachua, for example, has a historic downtown district that is listed on the National Register of Historic Places.

The University of Florida is the largest employer in the county and a major economic driver. In addition to the university, Alachua County has a diverse economy that includes healthcare, technology, and agriculture. The county is also home to several natural attractions, such as Paynes Prairie Preserve State Park and the Santa Fe River. These natural areas offer opportunities for hiking, biking, birdwatching, and other outdoor activities.

Alachua County is a diverse and welcoming community with a variety of cultural attractions, including museums, theaters, and art galleries. The county is also home to a thriving food scene, with a wide range of restaurants and cafes to choose from. LANGUAGE English

CURRENCY

The United State of America's national currency is the US Dollar (USD). Currency exchange is available at banks, international airports and currency exchange offices. Banks offer the same range of services typical in other European nations, and cash withdrawal machines or Automated Teller Machines (ATMs) are widespread. Payment with cards: VISA, MasterCard, American Express and Discover Card are available in most of shops, restaurants and other points of sale.

TIME ZONE

Alachua County is in the Eastern Time Zone, but during the WMACi25, it will be Eastern Daylight Time or EDT, which is GMT-4.

ELECTRICITY

Main voltage in Alachua County is 120V. If your country does not use the same main voltage as the United States, you need a power adapter.

WATER

Tap water in Alachua County (unless otherwise indicated) is safe for consumption.

CALLING ABROAD

If you are expecting a call from abroad, the international country code for USA is +01 and the area code for Alachua County is 352. If you wish to call abroad, you must dial "011" and then the country code of the destination country, then the area code (if applicable), and finally the phone number itself.

CLIMATE

March in Alachua County, Florida is a pleasant time of year with mild temperatures and increasing sunshine as sprint approaches. Expect daily high temperatures to be in the low-mid-70's Fahrenheit (around 22-25 degrees Celsius). Overnight lows will likely be in the mid-50's Fahrenheit (around 13-15 degrees Celsius). Precipitation (rain fall) in March is minimal, with an average rainfall during the last month of March being 6.6mm or .26 inches. Humidity can range from 57% - 81% depending on the day.

WIFI

Most businesses and locations throughout Alachua County offer free WIFI and cellular coverage is available throughout.

SMOKING

The Florida Clean Air Act (FCAA) is a state law that prohibits smoking in most public and private businesses, including restaurants. This law was enacted in 1985 and amended in 2003 to include a voter-approved amendment that prohibits smoking in workplaces that previously allowed smoking. The FCAA also prohibits vaping and the use of e-cigarettes in workplaces. In addition, Alachua County does not permit smoking in any park or park property, near schools, and does not allow the purchase of smoking or vaping products by anyone under the age of 21.

DRIVING

Visitors to Alachua County, Florida may drive on a valid driver's license from your country of residence. Vehicles travel on the right-hand side of the road and the wearing of seat belts is required for all passengers. Florida law prohibits using a phone while driving, including texting, emailing, and instant messaging. Drivers must put their phones down and focus on driving, cannot manually type into a wireless device, and cannot use a wireless device while driving through school zones, work zones, or at designated school crossings.

ALCOHOL LAWS

There are strict laws regarding alcohol consumption in Alachua County. Alcohol cannot be purchased or consumed by anyone under the age of 21. Drinking and driving is strictly prohibited. Liquor stores can only sell liquor from 7am – 11pm and beer and wine from 7am – 2am. Restaurants, bars, and clubs can serve alcohol from 7am – 2am, seven days a week. You cannot consume alcohol in an open container on public streets, sidewalks, or parking facilities.

PUBLIC NUDITY LAWS

The State of Florida has public nudity laws and it is illegal to be naked in public, in a vulgar or indecent manner. Designated changing areas will be available at each venue. For liability reasons, the venues do not have public shower facilities.

TIPPING

In the United States, tipping is a customary practice in many service industries, particularly in restaurants. It is important to understand that tipping is not just a bonus for exceptional service; it is an integral part of how service staff, especially in restaurants, are compensated.

A standard tip in restaurants is 15-20% of the total bill before tax. If the service was exceptional, feel free to tip more. For delivery, 10-15% of the total bill before tax is customary. Tipping is generally not expected in fast-food restaurants or when you are simply picking up takeout.

SANITATION

Toilet paper should be flushed away.



COMPETITION VENUES

Competition will occur in two main locations in Alachua County. Celebration Pointe, located along I-75 and the Archer Road exit, is an entertainment and retail district which is home to the main venue, the Alachua County Sports and Events Center (ACSEC). All indoor track & field events will take place at the ACSEC and the start/finish of the 10K Road Race will be located just outside the Center. The 10K Race Walk will take place a short walk away, within Celebration Pointe.

The Cross Country and outdoor long throws (discus, hammer and javelin) will take place at West End, which was a golf course that has been purpose built for the WMACi25. West End is located across the street from the Town of Tioga and is within an area called Jonesville.

- 8-lane Mondo sprint lanes for 60m and 60m hurdles
- 2 Long Jump and Triple Jump competition areas
- 2 Throwing rings for weight/shot and shot put
- 1 Pole Vault competition area
- 2 High Jump competition areas
- Maximum allowable spike length is 1/4 inch (6mm or shorter is acceptable) on the Mondo surfaces and in the high jump area. Only pyramid spikes are permitted. Spikes are not permitted on the gray floor or common areas.

Parking

Celebration Pointe has two large parking garages to service the event. The North Parking Garage is the closest to the Alachua County Sports and Events Center, which is steps away from the Welcome Center and entrance to the Center. Parking is free. The South Parking Garage will serve as overflow parking. For both garages, all event parking will be on levels three (3) and above as the first and second floors of parking are reserved for Celebration Pointe tenants and employees.

Concessions

The Alachua County Sports and Events Center offers concessions with a variety of options, including healthy foods. In addition, the Center offers a bar with beer, wine, and liquor. 10K Road Race Course



LOCATION

The Welcome Center will be located at 4871 Celebration Pointe Avenue, Gainesville, Florida 32608. This is an empty retail space at Celebration Pointe which is centrally located to Medal Ceremonies, Athlete Village and the Alachua County Sports & Events Center. The Welcome Center will include Accrediation Declaration Confirmation and the Technical Information Center (TIC) services.

REGISTRATION PACK AND ACCREDITATION PASS COLLECTION

All registered athletes, accompanying persons and supporting personnel must collect their registration pack from the Accreditation area within the Welcome Center during operating hours. The registration pack will include an accreditation pass, competition handbook (if ordered), competition numbers (bibs) with pins, and pre-ordered merchandise.



STEPS TO COMPETE

Step 1

Visit the Accreditation area to obtain your bibs and accreditation before competing.

Step 2

Athletes must confirm by 17:00 the day before they will compete **except for Non-Stadia events** which require no confirmation. (A Confirmation Receipt will be provided at confirmation). Online confirmation is available at **www.wmaci2025.com starting March 16, 2025.**

Step 3

Report to call room at appropriate time prior to event start time. There is one call room for all events inside the Alachua County Sports and Events Center. See map of the Alachua County Sports and Events Center in the Appendix. All Non-Stadia events will have call rooms at their respective venues.

ACCREDITATION PASSES

Accreditation is a process designed to ensure that WMACi25 participants and guests are provided with the appropriate level of physical access to venues and areas. All registered athletes, accompanying persons and supporting personnel (e.g. media, medical staff, and team managers) will receive an event accreditation pass upon registering online. To collect their accreditation pass, registered athletes, accompanying persons and supporting personnel must present a passport or other government-issued identification (with picture included). Team managers are permitted to collect the accreditation of an athlete and make confirmation of events for an athlete.

The accreditation pass is only valid for the person to whom it is issued and cannot be transferred or sold. The WMACi25 accreditation pass must be always displayed in the designated WMACi25 venues/areas, except when athletes are competing.

The coding on each pass determines the access privileges provided to the person. Control points will be managed by contracted security, volunteers or staff. Access to the competition areas at each venue will be restricted to those with a valid reason and appropriate accreditation pass.

If a person violates the access control rules, the contracted security personnel will hold that person until a resolution is determined (e.g. revocation of accreditation).

ACCREDITATION FOR SUPPORTING PERSONNEL

The team managers' accreditation pass will allow them access to the team manager meetings and team managers' office. A physio staff accreditation pass will be issued to registered team sports medicine professionals (team physiotherapists). Suitable space will be dedicated to these services at the Alachua County Sports and Events Center.

Registered and accredited media (e.g. journalists, photographers, videographers etc.) will have access to a dedicated 'media zone'. See Media section for further information. The recognized Team Manager for each country shall collect all credentials for team support personnel (including physios, journalists, and managers) at the Welcome Center.

APPEALS

Appeals must be lodged at the Technical Information Center (TIC) at the Alachua County Sports and Events Center. Any appeal must be submitted in writing no more than two (2) hours after the posting of results. Where an appeal has been lodged, the medal presentation will be held over until the result has been officially declared.

INFORMATION

The information boards in the Welcome Center will display:

- General event information (e.g. transport)
- · Changes for competition times, if required due to unforeseen circumstances

LANGUAGE SERVICES

As the LOC in Alachua County will welcome guests from many different countries, providing language services is vital to ensuring a high level of customer service. The official language of the event is English, however, an effort will be made to have translation services for Spanish, German and French, in addition to other languages. Volunteers with these and other language skills will be available at the Welcome Center.

TEAM MANAGERS OFFICE & MEETINGS

The Team Managers Office will be located on the ground floor of the Hotel Indigo Gainesville – Celebration Pointe at 5020 SW 30th Lane, Gainesville, Florida 32608 in the Celebration Ballroom. All team managers meetings will be held in this room.

The first team managers meeting will be held on Saturday, March 22, 2025, at 14:30 and will include the Cross Country briefing.

On competition days, from Monday, March 24, 2025, to Saturday, March 29, 2025, team managers meetings will be held at 09:00 in the Team Managers office. There will be no team managers meeting on the first day & last day of competition.

All questions must be submitted on a Team Managers Form by 17:00, at the TIC. Reports from the daily team managers meetings will be posted on the WMACi25 website at www.wmaci2025.com.

SECURITY

GENERAL INFORMATION

The safety and security of all WMACi25 guests is an event priority. Contracted security guards and volunteers will maintain the security of all competition venues during the day and overnight.

Should you witness any incidents relating to security, please bring them to the attention of event staff or the closest security guard as a matter of priority. It is important to report every incident, suspected or real, to enable decision makers to take action to protect all WMACi25 guests.

PROHIBITED ITEMS AND PRACTICES

The following items and practices are prohibited at WMACi25 competition and event venues:

- Explosive devices
- Weapons
- Large banners, or banners with commercial messages or offensive references/language
- Use, possession and supply of Illicit drugs
- Unlawful use, unlawful possession and unlawful supply of prescription drugs
- Smoking
- The distribution of flyers or materials not approved by the WMACi25 Local Organizing Committee, whether for the purposes of promotion or any other communication
- Unauthorized tables, displays, and promotions or sales of goods and services
- Items or practices forbidden by law in Alachua County, the State of Florida and the United States of America

SECURE BAG DROP

Bag drop may be conducted upon entry to all competition and event venues. Should WMACi25 guests be found in possession of any prohibited items as detailed or found engaging or likely to engage in any unlawful, criminal, or inappropriate behavior, contracted security personnel or WMACi25 officials will have the right and authority to deny offending persons access to or to remove them from competition and event venues

BAG SEARCHES

A bag drop facility for athletes will be available at each call room. Though there will be general supervision of bags left at the designated bag drop, the WMACi25 is not responsible for any lost, stolen, or missing items.

GENERAL ADVICE

- Limit the amount of cash you carry with you.
- Keep a copy of your passport, travelers' cheques and credit card numbers separate from your wallet and your money.

LOST PROPERTY

Items found during the event will be stored at each venue, until the end of competition for that day. Each night, lost property will be transported to the Welcome Center at the Alachua County Sports and Events Center.

MEDAL CEREMONIES

Medals will be presented at the Promenade at Celebration Pointe on the same day as the event, including all non-stadia competitions. Medal ceremonies will generally be conducted after results have been posted at the end of the event. Athletes are requested to attend the medal ceremony in an outfit representative of their country.

During the medal ceremony, the athletes will stand on the dais, medals and diplomas will be presented to each athlete (first, second and third) and the first-place winner's national anthem will be played. A medal ceremony may be delayed if there is an appeal regarding the results of that event.

Medal Collection

Should an athlete not attend the medal ceremony of their event, they may collect the medal from the medal ceremony desk located close to the medal ceremony area until the end of the Championships. Team managers are also permitted to collect medals on behalf of their athletes.





MEDICAL SERVICES

EMERGENCY NUMBERS

911 – In the United States of America, all emergencies are called into "911" including medical emergencies. When calling, be prepared to state the nature of your emergency and your location.

FIRST AID AND MEDICAL RESPONSE

The WMACi25 Local Organizing Committee has contracted with UF Health of provide oversight of medical services at competition venues. The staff at UF Health are skilled in case of emergency. Maps and signage indicating medical locations will be displayed at all venues.

The priority of medical personnel is to offer first response, basic first aid, and transportation to a hospital if further car is deemed necessary.

Any health care services provided outside of these first aid facilities will be at a cost to the individual, including the cost of all health, medical, hospital and associated resources and services.

MEDICAL INSURANCE AND LIABILITY

All international visitors are strongly advised to obtain travel insurance, including medical coverage, prior to arriving to the United States of America. It is recommended that athletes and other tourists obtain any required vaccinations and check that their medical insurance covers travel and accidents in the USA. Athletes or National Federations are responsible for providing insurance for themselves or their delegations during the event. The WMACi25 Local Organizing Committee is not responsible for providing insurance nor for the absence of insurance.

The WMACi25 Local Organizing Committee accepts no liability for any claims of injury, illness, or death arising from the traveling to and the participation in the WMACi25 nor any claims relating to the cancellation of the event or medical costs related to illness or injury that may affect a participant during the event.

PHYSIOTHERAPY SERVICE

In the Alachua County Sports and Events Center, the WMACi25 Local Organizing Committee will provide a dedicated physiotherapy area where accredited physiotherapists who are supporting their country's team can install their massage tables.

The WMACi25 Local Organizing Committee may be able to provide referrals to national federations who cannot travel with their medical support personnel. The WMACi25 Local Organizing Committee will not provide physiotherapy services to individuals from countries which do not have their own medical support personnel.

No third party physios will be permitted to sell their services or to set-up within the competition venues and surronding areas. Physios who wish to be on site to provide and sell services may purchase a vendor booth at the Athlete's Village. Email info@wmaci2025.com for vendor information.

PHOTOGRAPHY

The official event photographer will provide a professional photography service. The official photographer will have exclusive access to the field of play, except for accredited media. Official photographers will be required to always wear an official photographer's bib while on duty.

MERCHANDISE

WMACi25 merchandise will be available for sale during the event by Karhu, the official on-site merchandise provider for WMACi25. The WMACi25 on-site merchandise booth will be located at the Athlete Village outside of the Welcome Center. All media representatives attending WMACi25 MUST be accredited. The media accreditation pass will provide access to spectator areas and dedicated media zones within a venue. Media zones include media viewing and work areas at competition and event venues, as well as the Media Center. Approved media credentials will be available at the Media Center.

Accredited media will have the opportunity to book field of play opportunities at the Media Center. Spaces are limited, and early bookings are encouraged. To access the field of play, accredited media must have made a booking, be wearing a media bib (sourced from the Media Center) and be escorted by a media volunteer.

COMPETITION INFORMATION

ENTRIES AND COMFIRMATION

FINAL ENTRIES

Visit the 2025 World Masters Athletics Indoor Championships website at www.wmaci2025.com.

CONFIRMATION OF ENTRIES

Athletes must confirm by 17:00 the day before they will compete except for Non-Stadia events which require no confirmation. There are three ways to confirm events for the WMACi25. Online confirmations will open on Sunday, March 16, 2025.

Confirmation Option #1

Visit the Confirmation Desk at the Welcome Center, during the hours of operation. A confirmation receipt will be provided upon confirming at the Confirmation Desk.

Confirmation Option #2

Login into your Simply Register account at https://www.simplyregister.net/register/?e=126375 using the same link, user name, and password as you did for registration. This link can also be found at www. wmaci2025.com. Select "Manage My Registration", login, and then confirm/scratch.

Confirmation Option #3

Simply Register will send an email (to the email address you entered when you registered) on Sunday, March 16, 2025, to all registered athletes, with a link to confirm online without having to login into your account. Please be sure that **confirmation@simplyregister.net** is added to your address book or friends list and be sure to check your SPAM or Junk folders frequently for important information.

CHANGE OF EVENTS

Participants are not allowed to change or add events. Athletes may only cancel their events, for which they were registered. Athletes cannot take the place of another athlete in an event. In the case of non-compliance with these rules, the athlete may be disqualified from the entire competition.

WARM-UP AREAS & TRAINING

WARM-UP AREAS

For Indoor Track events held in the Alachua County Sports and Events Center, the only warm-up area is listed as number 6 on the map found on page 24 of this handbook. This area is to be used to warm-up prior to reporting to the call room. Last warm-up is at the location of your event.

There are no separate warm-up areas for field events. Warm-up will be at the competition area supervised by competition judges.

TRAINING

Alachua County Sports and Events Center

The WMACi25 Local Organizing Committee has arranged opportunities for athletes to train at the Alachua County Sports and Events Center (ACSEC) from March 3, 2025 – March 19, 2025. The ACSEC will offer a morning and afternoon session as follows for a per athlete fee of \$10 per session or \$200 for unlimited sessions. Athletes must request their training passes in advance. Visit www.wmaci2025.com/training/ to register online and in advance. Indoor throwing facilities will not be available for training. Note: in order to prepare for competition and the Opening Ceremony, the facilities at ACSEC will not be accessible from March 20, 2025 until 5:30pm on March 22, 2025 by competition judges.

West End

West End will be open for cross country course inspection and training on March 22, 2025 from 09:00 – 12:00.

West End throwing facilities will be available for outdoor long throws training on March 23, 2025 from 15:00-18:30. From March 24 – 29, 2025, West End will remain open for outdoor long throws training daily at the conclusion of all competitions until the last shuttle departs the venue at 18:30. No training or practice will be permitted until all competitions at West End are completed and officials have deemed the facilities open for training.

EQUIPMENT & IMPLEMENTS

USE OF OFFICIAL AND PERSONAL IMPLEMENTS

The WMACi25 Local Organizing Committee will provide at least three (3) WA/WMA compliant implements for each throwing event.

Personal implements are permitted for competition, provided they have previously been officially checked and certified by the Judge at the competition venue equipment control room (implement inspection). Personal implements shall only be issued to the specific competition of their owners. Any other competitor in the owner's specific competition has the right to use that equipment if they wish. Only indoor shot puts and weights will be used for indoor competition. No outdoor (metal) implements will be permitted indoors. If your event starts after 10:00, the deadline for certification of personal implements for the Pentathlon and Throws events is two (2) hours before the start of your age group, at the venue of the event. If your event starts before 10:00 the deadline will be one (1) hour before.

Athletes may collect their personal implements at the end of the event from the equipment control room (implement inspection) at that venue. Meet implements and personal implements which will be used for the final will go to the final and will be returned to the equipment control room (implement inspection) after the final.

EQUIPMENT CONTROL ROOM (IMPLEMENT INSPECTION)

The equipment control room (implement inspection) will be open during regular venue operating hours on the days of competition. The equipment control room (implement inspection) at West End for the outdoor long throws, will first open on March 23, 2025 following the conclusion of Cross Country competition estimated at 15:00.

POLES

For the convenience of athletes, the WMACi25 Local Organizing Committee has partnered with the Florida Pole Vault Factory (FLPVF) to provide pole rentals on-site. The FLPVF has an expansive inventory of almost 200 poles including Pacer One, Fiber Sport, Pacer FXV, UCS Spirit, Pacer Composite, and ESSX. Rental poles will be available for use during competition and must not be taken from the venue, otherwise the athlete will be responsible for cost of replacement. For more information and for online pole rental, please visit www.wmaci2025.com/training/

Athletes bringing their own poles for competition may bring their poles to the competition site no later than two hours prior to their scheduled event start time on the day of competition. Poles must be identified with the athlete's bib number. The WMACi25 Local Organizing Committee bears no responsibility for lost, stolen or damaged poles.

COMPETITION PROCEDURES

RULES OF COMPETITION

The World Masters Athletics Championships are governed by the WMA Rules of Competition and the technical rules of the WA. The WMA Rules of Competition are available online at https://world-masters-athletics.org/wp-content/uploads/2024/09/WMA-Competition-and-Technical-Rules-2025.pdf.

CALL ROOM PROCEDURES

Athletes must report to the Call Room, at the latest, at the times shown below:

EVENT	CALL ROOM (MINUTES BEFORE EVENT)
All Track Events	20 minutes
Indoor Long Jump, Shot Put, Triple Jump and Weight Throw	35 minutes
Indoor Pole Vault	65 minutes
Indoor High Jump	40 minutes
Indoor Pentathlon	20 minutes (first event)
Outdoor Discus, Hammer and Javelin	35 minutes
Non-Stadia Events	75 minutes

Once athletes have reported to the Call Room, they will not be permitted to leave, except for Non-Stadia events. Non-Stadia event athletes can leave the call room. All necessary information concerning the competition will be provided to the athletes in the Call Room. The Call Room officials will verify the accreditation, competition number, uniform, shoes and personal effects of the athletes. All athletes will be escorted from the Call Room to the competition area.

Languages

English will be the primary languages spoken in all WMACi25 Call Rooms. Officials speaking other languages may also be available. If necessary, athletes may report to the Call Room with an accredited translator.

Uniform

In WMA Championships, all athletes MUST wear a competition top that is approved by their national Masters Member. In WMA Championships where team events are contested, or where an athlete does not have an affiliate Masters Member, it is mandatory to wear a uniform clearly identifying the country that he/ she represents in order to be accepted by the Call Room Referee or the WMA Technical Delegate.

A club singlet or vest is not acceptable. All advertising on the uniforms of the athletes during the competition and the awards will be in accordance with the rules of the WA and WMA regarding the size and content.

Competition Numbers (Bibs)

All athletes will receive three bibs and twelve (12) pins in their registration pack, which must be collected from the Accreditation Center in the Welcome Center.

In all competition, the athlete must wear two bibs, properly attached to their competition top, with one bib on the front and one on the back. The exception is for jumps and throws, where the bib may be placed on the front or back or both.

The bibs must not be cut, bent or otherwise modified, under penalty of disqualification. In relay events, athletes wear their own competition bibs. Any replacement bib will be charged at a fee of \$15 USD. Replacement bibs can be purchased at the Welcome Center.

Timing Chips

Non-Stadia events, 3000m, and 3000m Race Walk timing chips will be distributed to athletes at the time of accreditation and will be attached to their bib number, which must be worn on the front. Athletes losing their timing chip may obtain a replacement at their respective Call Room for a replacement fee of \$10 USD.

COMPETITION SITE EXIT PROCEDURES

In the high jump and pole vault events, athletes are permitted to leave the competition area after they have been eliminated.

In the Pentathlon, athletes will leave the track after the event, with a Judge. There will be toilets available for athletes during the championship, but it is necessary to be accompanied by a Judge or a technical assistant to use the toilets during the competition.

All athletes must leave the competition area and proceed through the post-event area where track athletes will collect their personal belongings.

DISPLAY OF RESULTS

The results will be displayed at each competition venue where the events are conducted. Results will also be available on the website at www.wmaci2025.com on the results page. A hard copy of individual results will be available for sale at the Welcome Center.

PERSONAL ITEMS

Athletes are not allowed to take into or use in the competition area tape recorders, radios, cell/mobile phones, cameras or any other electronic devices. These items will be confiscated and may be recovered in the post event control room at the end of the event.

Any advertising on the uniforms or bags of athletes must be in accordance with WA rules. Every item not in accordance with these rules will be confiscated and returned at the end of the competition.

SPIKES AND SHOES

The call room staff will be responsible for checking the legality of shoes as well as spikes on the athlete's shoes. WMA rules state that shoes for competition must have a maximum sole depth of 40mm (except any shoe that contains spikes must have a sole with a maximum thickness of no more than 30mm). The maximum length spikes for Indoor events will be 1/4 inch (6mm or shorter is acceptable). The maximum length spikes for the Outdoor javelin event will be 3/8 inch (9mm or shorter is acceptable). Only pyramid spikes are permitted.

SEEDING FOR HEATS

There may be heats for running/hurdling events with several rounds from the 60m up to and including the 1500m, and athletes will be assigned to heats according to the time provided with their entry. For events with several rounds, the first round (Heats) will always be conducted at the scheduled time listed in this book. If a round needs to be cancelled because of withdrawals, the middle round (Semis) will be cancelled. Finals will always be conducted at finals time.

For longer races with direct finals, athletes will be seeded (ranked) and placed into separate sections based on their time. The slower section will be conducted first. The final results will take into account all finals and will rank the athletes by time

ADVANCEMENT PROCEDURE

See Appendix for advancement tables. Please note that the 400m advancement table has been modified.

COMPETITION SCHEDULE

The Competition Schedule by day and by site is provided in the Appendix or is available on the website at www.wmaci2025.com.

RESULTS AND RECORDS

The WMA Records Officer automatically records the world records broken during the championships. For enquiries about national records, athletes should contact their team manager.

POST-COMPETITION PROCEDURES

Results for each venue will be posted at that competition site. All certified final results will be posted online at www.wmaci2025.com.

PROTESTS AND APPEALS

Protests and appeals must be made in compliance with the rules of the WA and WMA as modified below and appeals submitted no later than two (2) hours after the display of the results. Results will be displayed at each competition venue. A protest is an immediate disagreement about any aspect of any event. An appeal is a disagreement with a Referees' decision about a protest. There cannot be an appeal without a protest being held and a Referee decision.

PROTESTS

Protests concerning the status of an athlete to participate in the championships must be made to the Competition Director, prior to the commencement of the competition. Should the matter not be settled satisfactorily before the start of the event, the athlete shall be allowed to compete "under protest". The problem will then be referred to the WMA Council for a final decision.

Protests concerning the conduct or the result of an event should be made immediately to the Judge, preferably the Head Judge, of that event. Judges will do everything possible to preserve the rights of the athlete such as provisionally measuring throws or jumps.

APPEALS

If the athlete does not agree with a decision made by the Referee, the athlete or their team manager may then make a written appeal to the Jury of Appeal. Any appeal must be lodged at the TIC at the Welcome Center. The time limit for lodging an appeal is two (2) hours from the time the results are posted.

The Appeal shall be in writing using the form provided for this purpose. The forms can be requested from the TIC. The form should be signed by the team manager, the athlete or official acting on behalf of the athlete concerned.

A deposit of \$100 USD will be required to confirm the appeal. If the appeal is not upheld, the deposit of \$100 USD will not be returned.

An appeal can only be lodged at the TIC. The Appeal Panel shall issue a written decision. The decision of the Appeal Panel will be available at the TIC.

STARTING BLOCKS, STARTER'S COMMANDS & FALSE STARTS

STARTER BLOCKS

Starting blocks are not mandatory, but only starting blocks provided by the WMACi25 Local Organizing Committee will be allowed.

STARTER'S COMMANDS

In accordance with WA rules, the starter will give the commands in English. For races up to and including 400m and 4x200m relays, the commands will be:

- "On your marks"
- "Set"
- Electronic Gun / Pistol

For races from 800m and longer, the commands will be:

- "On your marks"
- Electronic Gun / Pistol

FALSE STARTS

For running events, any athlete who makes a false start will be warned with a yellow/black card. Athletes who commit two false starts will be notified by a red/black card and will be eliminated from the competition. This rule also applies to Combined Events.

COMPOSITION OF FINALS

See race advancement procedure tables in the Appendix. For races longer than 1500m, there will be direct finals.

TRACK RELAYS

For this Indoor championship, athletes have the opportunity to compete in two (2) Track Relay events.

- 4 x 200m Relay (Men and Women, separate events in each age group)
- 4 x 200m Mixed Relay (two males, two females in each age group)

The relay races shall be conducted in five-year age groups between teams entered by the country's designated team manager. Each country may enter only one male and one female team in each age group for each relay. An athlete may compete for a team only once in each relay event, which may be a lower age group than that of the athlete. The age group of the team is the age group of the youngest athlete on the entry form and an athlete from that age group must compete in the relay.

In the mixed relay, two (2) males and two (2) females shall comprise the relay team and four (4) alternates comprised of at most two (2) males and two (2) females may be listed in the entry form. The mixed relays must complete in the following order: female-female-male-male. An athlete who has competed in the 4 x 200m Relay may also compete in the 4 x 200m Mixed Relay. An athlete may compete in a lower age group than that of the athlete. The age group of the team is the age group of the youngest athletes on the entry form and each relay must compete at least one (1) male and one (1) female of the age group of the team. Entries for teams in both Relays must be made using the official form available from the TIC. The Team Manager must hand in the completed form to the TIC before the deadline for each relay.

The 4 x 200m and mixed relay entry forms are due before 12:00 on Saturday, March 29, 2025. Any changes to the running order, or the alternates listed on the relays form can be submitted by the Team Manager at the TIC up until two (2) hours before the event start, but no new relay teams or names will be accepted. In case of a last-minute injury, the Call Room Referee has the authority to approve a listed substitute.

Affiliates who do not have a team manager should submit their forms directly to the TIC. Relay teams comprising members of several countries will NOT be allowed to run.

FIELD EVENTS

VERTICAL JUMPS

All vertical jump events will be direct finals. There will be no qualifying rounds. For high jump and pole vault, both feet must be off the ground during the jump. Athletes are allowed to touch the landing area before clearing the bar but may not use the landing area to any advantage as determined by the field judge.

STARTING HEIGHTS & PROGRESSION IN THE COMPETITION

The starting heights and progression through the competition are detailed in the Appendix. The competition will NOT start at a height lower than the equipment permits.

HORIZONTAL JUMPS AND THROWS

The event will be conducted as a final. There will be no qualifying rounds. If the entries require 2 or more groups, each athlete will have 3 jumps or throws in their group. Group 2 will be the athletes with the best submitted marks and compete last. After the completion of all groups, the 8 athletes with the best performances will have a further three trials.

PENTATHLON

Athletes will only move from one competition area to another as instructed by the Combined Events Referee. The Referee will be the official source of information for the location and schedule of events. The Referee will announce the results to the participants at the end of each event.

Depending on the number of declared athletes, several groups of the same age group can be formed.

NON-STADIA EVENTS

6K and 8K Cross Country | 10K Race Walk | 10K Road Race

AWARDS

Medals will be awarded to the first three individuals in each age category, men and women. There will be first three team award in all events. All medal presentations will be in the Athlete Village at Celebration Pointe.

CALL ROOM

The call room officials will check bid numbers, uniforms and shoes. Chips must be worn on the front bib. The call room for each category will open 75 minutes before race start time and close 20 minutes before the start. Start times can be found in the competition schedule in the Appendix of this handbook. Once athletes have reported to the call room, they will be permitted to leave.

Athletes who do not have their chip will not be allowed to compete.

CONFIRMATION

There is no confirmation for non-stadia events, but athletes must report to the call room.

BAG DROP

A secure bagdrop facility will be available near the call room. Personal bags must be clearly labelled with their bib number. Though this area is secure, the WMACi25 Local Organizing Committee bears no responsibility for damaged, lost, or stolen items.

MEDICAL

Medical staff will be located at the finish and with monitoring around and access to the course.

CROSS COUNTRY COURSE INSPECTION AND BRIEFING

The course will be ready for inspection on Saturday, March 22, 2025, 09:00 – 12:00. Please see the transportation section of this handbook, but athletes are ultimately responsible for their own travel arrangements to West End.

Cross County course briefing will be at the first team managers meeting scheduled for 14:30 on Saturday, March 22, 2025. Declared composed team will still have to be submitted to the TIC before the 17:00 on Saturday, March 22, 2025 deadline.

PACING

This is considered a warning/yellow card. Pacing by athletes in the race or other persons not in the race is not allowed. Athletes may and can be given a red card for the infraction during or after the race.

PROTESTS

Protest and appeals must be in compliance with WA and WMA rules. Appeals must be submitted in writing no later than two (2) hours after to display of the results. The results must be submitted to the TIC with \$100 USD cash. The race referee must be consulted first.

RACE WALK

Athletes can be disqualified during or after the race. The WA penalty zone will be used.

Race Walking Penalty Zone

An athlete will be required to enter the Penalty Zone and remain there for one minute once they have received three Red Cards and are so advised by the Chief Judge or someone delegated by them. An athlete who fails to enter the Penalty Zone when required to do so, or remain there for the applicable period, shall be disqualified by the Referee.

If an athlete receives a third red card and it is no longer practicable to direct them to the Penalty Zone before the end of the race, the Referee shall add the time they would have required to spend in the Penalty Zone to their finishing time and adjust the finishing order as may be necessary.

RESULTS

Results will be online at www.wmaci2025.com under the results page.

REFRESHMENTS

No refreshments are to be issued outside the refreshment zone. Water will be available at the end of each lap in the Cross Country, Race Walk, and 10K Road Race and at the finish.

SAFETY OFFICER

The safety officer has the authority to withdraw any athlete considered to endanger their health or the safety of other competitors. They will be disqualified in accordance with WMA 3.21.

SHOES

The call room staff will be responsible for checking the legality of shoes, as well as spikes on the athletes' shoes. WMA rules state that shoe's for competition must have a maximum sole depth of 40mm (except any shoe that contains spikes must have a sole with a maximum thickness of no more than 30mm).

START TIMES

Check the competition schedule found in the Appendix of this handbook.

TOILETS

Available near all event call rooms.

WARM-UP

Strictly no warming up on the course when a race is in progress.

NON-STADIA TEAM SCORING

Non-Stadia team scoring will be conducted in accordance with WMA Rules of Competition Rule 13. Team awards are based on the combined times of the three scoring athletes of that country in each age group. If there are three (3) or more athletes in the same age group (a natural team), the registration of a team is not required. In this situation, if a composed team is registered, the age category team is disqualified.

WITHDRAWAL PROCEDURE

Safety Officers or their appointed Deputies will initially orally speak with the athlete to alert them of safety or health concerns, or, if appropriate, issue a yellow card warning to the athlete. If the concerns continue and a decision is taken to remove the athlete from the competition because of health and or safety reasons, a RED card will be shown to the athlete as well as an oral instruction, advising the athlete that they have been disqualified. The athlete must then immediately cease to participate in the event and leave the competition area. The decision to remove any athlete will appear in the results as a DQ, in accordance with WMA Rule 3.2.

ANTI-DOPING PROCEDURES

ANTI-DOPING CONTROL

WMA has engaged the services of USADA to undertake drug testing as part of the WMA Indoor Championships. Drug testing will be conducted under the WA/WMA Rules that comply with the provisions of the World Anti-Doping Agency (WADA). Representatives of WMA and USADA will be supervising the antidoping operations.

Selection Process

The selection of athletes for testing is randomly made and any athlete regardless of their age and sex and the type of event in which they are participating may be chosen. The Procedural Guidelines established by WADA are strictly adhered to in the testing of all athletes.

If you are selected for a test, you will be advised of this fact by a drug testing official (DCO or Chaperone) who will be clearly identified and accredited as part of the testing team. You will be informed of your selection to undergo a doping test and the drug testing official will then escort you to the testing control area. All competitors should be aware that the refusal of a test will be deemed the same as a positive doping test.

Testing Procedures

The testing procedure will be fully explained to you by the control team, and you may request information on any matter about the drug testing procedure, during or after completing the required forms. Any queries or complaints should be noted before finally signing the forms.

If you have been granted a Therapeutic Use Exemption (TUE) you should carry a copy of the exemption with you as proof when being tested and provide details on the drug testing form.

Athlete's Rights

An athlete is normally advised of their selection for a drug test immediately after they have completed an event. The drug testing official (DCO, Chaperone) who advises you of the selection will then remain with you until such time as you are presented at the testing control area.

You may nominate another person (one only) to accompany you to the drug testing process. With the consent of your drug testing official, and at all times in full view of the official, you may:

- Attend a victory ceremony
- Compete in future events
- Receive necessary medical attention
- Fulfill media commitments
- Warm down (cool off) or recuperate

Athlete's Responsibilities

It is the athlete's responsibility to ensure that the following is done during the sample collection process:

- You are aware of and comply with the WA/WMA/WADA doping control regulations
- You comply with the drug testing procedure
- You control the urine sample until it is sealed in the sample collection kit
- · The sealed sample collection kit is secured and identified
- All appropriate documentation is accurate, complete, and signed

Note: If any part of the drug testing procedure concerns you it is recommended that you record your concern on the drug testing form and notify your Team Manager or Federation.

This form should be with you at all times and should not be given to anyone else.






10K ROAD RACE COURSE
